RE: Executive Order / Declaration expanding sales tax spending authority The City of Santa Fe 4B Economic Development Corporation

Dear Honorable Sirs,

The City of Santa Fe 4B Economic Development Corporation ("Santa Fe EDC") and its authorizing city want to do everything possible for Santa Fe's local businesses and community during this public health disaster and crisis. Locally owned businesses desperately need our financial assistance to meet essential expenditures such as rent and utilities; public safety is also a concern as the City is increasingly burdened by the increased demand for law enforcement during this time. In Santa Fe, the ability to access any and all financial resources available to the Santa Fe EDC and the City is almost tantamount to fighting the COVID-19 virus itself.

The Santa Fe EDC is a Type B non-profit economic development corporation and administers the one-half cent sales tax the Santa Fe voters approved in May 2001. However, the voters only authorized expenditures for limited economic development projects relating to "public works infrastructure improvements, specifically water/wastewater expansion, drainage, and streets and roads, including the maintenance and operating expenses for those projects development with economic development funds designed to promote new or expanded business enterprises." Prior to the pandemic, the City and the Santa Fe EDC authorized a special election in May 2020 to expand the EDC's spending authority to include the full breadth of economic development projects allowed under the Texas Local Government Code. However, the May elections are now postponed.

The City of Santa Fe and its EDC need your help to temporarily expand the Santa Fe EDC's spending authority while the Governor's state-wide disaster declaration is in place. Specifically, the City and the Santa Fe EDC request an executive order, declaration, or other formal action to temporarily expand the Santa Fe EDC's spending authority to include programs and projects that

would assist local businesses during the COVID-19 crisis, including but not limited to projects for the general promotion and development of new or expanded business enterprises, which may also include projects that promote or develop specific new or expanded business enterprises pursuant to Texas Local Government Code Ch. 501, Subchapter C, and Ch. 505, Secs. 505.155 and 505.158.

Governor, you have the power to grant our community the relief it needs during this unprecedented time. Last week you relied on Texas Government Code Ch. 418 to issue a disaster declaration for all 254 Texas counties, which gave you additional powers over state agencies and boards of commissions as the number COVID-19 cases increased statewide. According to Sec. 418.016, the governor has the power to suspend the provisions of *any* regulatory statute prescribing the procedures to conduct state business or the orders or rules of a state agency if strict compliance with the provisions, orders, or rules would in any way prevent, hinder, or delay necessary action in coping with this COVID-19 disaster. Further, Sec. 418.017 allows the governor to use *all* available resources of political subdivisions that are reasonably necessary to cope with a disaster.

The Santa Fe EDC is a resource available and ready to serve the City, its constituents, and its local businesses in any way possible during this crisis – we just need you to exercise your authority to grant us the temporary power to use the Santa Fe EDC's financial resources for all legal purposes under Chapters 501 and 505 of the Texas Local Government Code during the pendency of your disaster declaration. Please help us help our community.
