The application for a permit required by the provisions of Ordinance # 07-2011 by a vendor who can not provide satisfactory proof of reputable dealings with the public, has a history of prior complainants, civil or criminal charges and arrests shall be accompanied by a bond for the penal sum of \$2,000.00, signed by the applicant and signed, as surety, by a surety company authorized to do business in this state, conditioned for the final delivery of goods, wares, merchandise or services in accordance with the terms of any order obtained prior to delivery and also conditioned to indemnify any and all purchasers or customers for any and all defects in material or workmanship that may exist in the article sold by the principal of such bond, at the time of delivery, and which bond shall be for the use and benefit of all persons that may make any purchase or give any order to the principal on such bond, or to an agent or employee of such principal.
