A subdivision of Abstract 15 I Lewis Survey Part of Block A (1-1-3) Eureka Orchard Subdivision Number 1. Located on the east side of Tower Road, approximately 1,300 feet north of Williams Street, Santa Fe, Texas.

City Engineer Matthew Johnson presented the final plat of Tower Road Estates Phase III, including 36 lots and 2 reserves on 1 block. Mr. Johnson noted the title block on the final plat reads 36 lots, 1 block, and 2 reserves, which will be corrected to show 36 lots, 1 block, and 3 reserves on the mylar.
