iii. Consideration and possible action regarding SD 230301 – a request to vacate the YOUNG ACRES Minor Plat.

Chief Building Official/Acting Director of Community Services Ray Burgess presented the item, explained the plat vacation process, and provided a brief history of the property. Mr. Burgess recommended that the Commission approve the request to vacate the plat and said that, if the request is approved, the property owner plans to replat the lot into larger parcels than currently exist.
