- 4. Consideration and Possible Action regarding approval of meeting minutes for May 1, 2018. Motion to approve by Vince Megale and seconded by Ronnie Willoughby. Motion passed unanimously.
- 5. Public hearing, consideration and possible action regarding SD 180501 Esther's Place, a subdivision of 4.924 acres, 2 lots, 1 block being a replat of Lot 4 of the McGhee subdivision; located at 4817 Avenue P, City of Santa Fe, Galveston County, Texas

According to Mr. Skaggs, the mortgage company will not lend money for the home site as it is zoned commercial. Therefore, they are seeking to rezone just the home site so a mortgage can be obtained.
