Tim Clark, 3620 Avenue F, thanked the Commission for its efforts. Reminded board that it can postpone items for the future of indefinitely. Clark asked the Commission to take the time to understand what they are doing.

The minutes of the 09/12/2022 regular meeting was approved as presented.

VI. VARIANCES

BOA 220901: PUBLIC HEARING, CONSIDERATION AND POSSIBLE ACTION REGARDING BOA 220901 A VARIANCE REQUEST REGARDING SECTION 4.02.04.E REAR YARD, OF ARTICLE 4. – ZONING DISTRICTS OF THE CITY OF SANTA FE, TEXAS ZONING ORDINANCES.

Public hearing opened at 7:08 by Commissioner Dawn Sharp.

City Engineer Matthew Johnson introduced item- applicant constructed slab and metal garage without permits, six inches to one foot from property line, when there should be a fifteen-foot set back. Previous building official discovered this issue. May 2022, applicant applied for building permit. Mr. Johnson read letter from adjacent property owner (M.A. Mazoch) expressing concerns about draining issues that the building has raised. Mr. Johnson said the structure was worked on after the building permit was applied for. Not sufficient room to get between the fence and the building to be able to cut weeds down and avoid any sort of rats or rodents making a home between the buildings. Staff does not recommend approval.

Applicant, James Browning, 10811 28th St., said he was unaware of the need for a permit, as he did not run utility services to it. He stopped work on the building when Marty Haley asked him to stop.

Mr. Johnson explained the six considerations BOA should use in arriving at its ruling. Applicant states in response to the questions, that he can weed eat between the building and the fence. There used to be a trailer in a similar location years ago as part of a daycare. Mr. Johnson going back to 2015, no structure there in aerial images. The contractor is a crew sent by Eagle Carports.

Tim Clark- why doesn't BOA postpone this proceeding a possible solution presented by mutual agreement with his neighbor?

Closed at 7:27 P.M.

Board discussed risk of setting precedent by approving request.

Commissioner Craig Thorton Wright motioned to deny request, Commissioner Alec Dobson seconded. Motion carried.

Applicant thanked board for its consideration.
