- V. VARIANCES
 - a. **Public Hearing BOA 221101** a variance request regarding sections 4.02.04.E Rear Yard and 4.02.04.F Side Yard, of ARTICLE 4. ZONING DISTRICTS of the City of Santa Fe, Texas Zoning Ordinances.

The public hearing was opened at 7:04p.m.

- i. Request: to allow a structure constructed within the 15-foot rear yard building and 6-foot side yard setbacks to remain in its current location.
- ii. Location: 15730 North Tower Circle, Santa Fe, Texas; Lot 31 Block 1, Tower Road Estates Phase II.

City Engineer Matthew Johnson explained that the structure, which is bolted down to a concrete slab, is located in a CenterPoint easement. Mr. Johnson also explained the city's ordinance regarding setbacks.

The public hearing was closed at 7:14p.m.

- b. Consideration and possible action regarding BOA 221101 a variance request regarding sections 4.02.04.E Rear Yard and 4.02.04.F Side Yard, of ARTICLE 4. ZONING DISTRICTS of the City of Santa Fe, Texas Zoning Ordinances.
 - i. Request: to allow a structure constructed within the 15-foot rear yard building and 6-foot side yard setbacks to remain in its current location.
 - ii. Location: 15730 North Tower Circle, Santa Fe, Texas; Lot 31 Block 1, Tower Road Estates Phase II.

Mrs. Tamara Loftin, 15730 North Tower Circle, Santa Fe, Texas, explained they hired a company to install the structure, but the company they hired did not get

proper permits to build the structure. Mrs. Loftin explained that if there were any need for CenterPoint to access the easement, she would be fully responsible for the removal of said structure. Commissioner Dawn Sharp expressed concern with the commission being unable to grant a variance on property that was owned by CenterPoint.

Commissioner Alec Dobson suggested Mrs. Loftin get a consent to encroachment from CenterPoint, which gives permission to encroach in a portion of a dedicated or an acquired easement.

Mrs. Dawn Sharp motioned to postpone item **BOA 221101** to give Mrs. Loftin the opportunity to get the consent to encroachment from CenterPoint, Commissioner David Unger seconded the motion. Motion granted to postpone agenda item.

c. **Public Hearing – BOA 221102** – a variance request regarding Section 4.02.04E Rear Yard, of ARTICLE 4. – ZONING DISTRICTS of the City of Santa Fe, Texas Zoning Ordinances.

The public hearing was opened at 7:30p.m.

- ii. Location: 10811 28th Street, Santa Fe, Texas; Abstract 48 L Crawford Survey Part of Outlot 426 (426-9) Alta Loma Outlots.

Mr. Browning, at 10811 28th Street, Santa Fe, Texas, had removed the previous structure from the concrete slab per BOA instructions and had purchased a new building to replace it, according to City Engineer Matthew Johnson.
