Public Hearing: BOA240719 Request for a variance at 11920 29th St, Santa Fe, Texas, legally described as ABST 68 L CRAWFORD SUR PT OF OUTLOT 195 (195-13) ALTA LOMA OUTLOTS, regarding City of Santa Fe Code of Ordinances Chapter 3-Construction Regulations, Section 20- Culverts, Drainage, Detention, Right-of-Way Drainage and Drainage Easements, Section E-Construction and Maintenance Affecting Operation of Public Drainage Systems, Subsection 4, which states that open bar ditches of city streets shall not be closed in an amount greater than forty percent (40%) of the lot or tract frontage width along any given street or fifty-six feet (56'), whichever is less, to preserve existing storm water detention capacity throughout the community.
